Sweeping the track after events would be helpful. He would like to be part of the process if improvements were made.

Director Hilton stated that there was a motion at the Town Council meeting for the Commission to come up with a recommendation for what the Parks and Recreation Department would like in a Community Center in Ninigret Park.

Commissioner Glista and Quillen suggested having a subcommittee to help prioritize the needs of the Parks and Recreation Department for the future.

Commissioner Glista suggested that the subcommittee approach the Town Council to clarify what they are proposing for the Parks and Recreation Department and Community Center. What are the priorities for the Community Center?

Commissioner Classey stated that vendor applications for the show have started to arrive.
