- IV. **APPROVAL OF MINUTES FOR SEPTEMBER 2, 2021 MEETING:** One edit was noted. Gary Gardiner made motion to approve the minutes as amended and Anthony Feisthamel seconded the motion. The motion passed unanimously.

Cost for storm damage was \$937.50 for 3 trees
 - E. **Patricia Sprague Preserve –**
 - 1. Cost for storm damage was \$690 for 8 trees
 - 2. Fireplace demolition has been changed to monitoring
 - 3. River Trail will be left as is. Revisit at a later time.
