**Recommendations to homeowners before having septic system inspected:**

- It is a good idea to get multiple bids before having your system inspected.
- Make all information needed in data collection step available to inspector.
- Ask inspector about discounts for inspecting and pumping at the same time.
- Ask the inspector about retrofitting septic tank with PVC risers to grade for ease in future inspections.
- Make sure that the inspector gives you a copy of the completed inspection report and a bill that details all charges associated with the inspection procedures.
- Ask inspector if discounts are available if you locate inspection ports on septic tank and remove soil covering ports.
- Make sure you are home when you schedule an inspection so that you can answer any questions the inspector might have.
