DISC GOLF BUDGET REQUEST

Item #	Item	Requested Amount	Description
1	Mowing	\$ 10,000.00	This item would allow for mowing, or a mowing contract, of the disc golf course throughout the mowing season. Work would be by contract or for fuel for volunteers with mowers.
2	Tee Pad Materials	\$ 4,295.00	This item will cover the cost of materials for the installation of Tee Pads. Tee pads are typically made with concrete. The course currently has 9 pads and is in need of 25 more. This amount would cover the material cost of Tee pads. Labor to install would be volunteered.
3	Signage	\$ 1,000.00	This item will cover the cost of materials to maintain and improve course signage and flag replacements.
4	Baskets	\$ 2,000.00	This item will cover the replacement cost of 4 baskets for the course. Estimated cost is \$500.00 each. There are 18 baskets on the course. Installation would be by volunteers.
5	Kiosk Sign	\$ 800.00	This item will cover the cost of a new waterproof bulletin board / kiosk for posting notifications and course rules. The old sign would be removed and the new sign would be positioned at the entrance to hole number one. Installation would be by volunteers
6	Dirt / Loam	\$ 500.00	Fill material for holes and deep ruts. This item would allow for approximately 10 yards of material at \$50.00 per yard
7	Sand	\$ 500.00	Fill material for 3 sand traps on holes 1, 8, and 10. Approximately 10 yards
