b. June 23, 2015 Parks and Recreation Commission Meeting Minutes

3. COMMENTS FROM PUBLIC

TM Dyer of the Ninigret Park Disc Golf Course spoke about the upcoming Disc Golf event. He mentioned some of the projects completed on the course including wood chip trails and tee boxes. Mr. Dyer reported that many of the people who were using the disc golf course were not from Charlestown and were not "hardcore" players.

4. TOWN COUNCIL LIAISON REPORT

There was no report, but Ms. Van Slyke thanked the Commission for attending the Master Plan meeting.

NEW BUSINESS

a. Ninigret Park New Pavilion Project Update

Chairperson Tim Quillen reported on the pavilion. He mentioned that the pavilion construction was started in July, after some setbacks due to building codes and designs and that the foundation was not constructed until June.

Mr. Quillen noted that there were a few problems with the equipment and hardware the manufacturer sent. He also noted that the area the pavilion is located at is used heavily in the summer and that there were too many people around continue construction. He mentioned that he had sought quotes for the construction.

b. Studying the Possibility of Combining the Bike Path Ad Hoc Committee's Linear Park with a Certified 5K Walking/Running/Activity Path Planned for Adoption into the Master Plan

Commission member Cheryl Dowdell noted that in the past couple of years many groups and non-profits have planned 5K races/walks in Ninigret Park and asked that the Revised Master Plan include a 5K course. Ms.

Dowdell noted a 5K trail would dovetail well with the current RFP for the 1.3 mile bike path. She asked that it be added to the Master Plan. She mentioned that it may be more cost effective to combine the existing Bike Path RFP with the planning of a 5K.

The Commission discussed the benefits of forming a Subcommittee over an Ad Hoc committee to expedite the plan and that it should include a minimum of 3 members.

The Commission then discussed the trail being a multiuse trail and that it would need to be maintained. It was noted that the Commission was not trying to hold up the Bicycle Path.

The Commission motioned to form a subcommittee to explore the possibility of combining the bike path plan with a 5K multiuse path.

c. Master Plan Discussion

The Commission members took turns discussing the previous and upcoming Master Plan meetings. The Commission discussed different issues including, that the document needed more work, that the festival area is leading to the workshops being unproductive, that the definition of the Plan is that it is an update and revised version of the 2008 Master Plan not a new Master Plan. The Commission discussed the public portion of the Workshop meetings and noted that it was not a public hearing. It was also noted that the Commission was charged with fixing the 2008 Master Plan and that the 2014 Plan is revisions.

The Commission discussed implementing a project that there is consensus on. Chairperson Quillen asked that there be a consensus on projects and that grants potentially be considered to help pay for the projects, but that the updated plan would have to be accepted first.

The Commission discussed working on the Master Plan one section at a time and coming to a consensus then possibly prioritizing each section. The Commission also discussed that if it went through section by section that the process may take too much time.

The Commission discussed the Master Plan being a living document and that the elements of the Master Plan are placeholders.

The Commission motioned to send Parks and Recreation Commission Communication through Chairperson Tim Quillen to narrow the focus of the next workshop going section through section working through the changes to the original Master Plan looking for consensus.
